Family Life Academy is a ministry of Christ Community Church serving families with children from toddlers through eighth grade. Our mission is to provide children and families with foundational Christian truths as the basis for all learning and to do this in a nurturing environment that is founded upon Biblical values. While striving for academic excellence, we will model and instruct from a Christian worldview, with creativity and integrity.

At FLA we place students in classrooms by chronological and/or developmental age.

Tuition Policy

Tuition is calculated on an annual basis, and then divided into monthly rates and billed as such. We do not provide sick or holiday credits.

Tuition may be paid weekly or monthly. If you choose to pay weekly, your balance is due each Monday. If you choose to pay monthly, your balance is due in full the first of the month. Tuition is considered late after the 15th of each month.

Payments

FLA utilizes FACTS Financial Management for account management and online payments. Families will have the option to choose either automatic monthly payments or to receive invoices. Automatic payments will be withdrawn on set days each month (typically the 1st). Invoices will be sent 20 days prior to the due date and payments can be made on a date of your choosing, on or before the due date.

ACH payments (from a checking or savings account) will have no additional fees. Payments made with a debit or credit card will have an additional 2.95% service fee added to the payment amount.

Unpaid Tuition

If a payment made on FACTS (automatic or invoice) is returned, FACTS will charge a \$30 returned payment fee. They will re-attempt the payment two additional times. The \$30 returned payment fee will only be charged at the first unsuccessful attempt.

All tuition must be paid by the 15th of the month. Unless other arrangements have been made, the total amount due must be paid before the student will be accepted back into class. If no arrangements or payments have been made, the child's name will be removed from the class roster. That child's slot will be filled by one from the waiting list. All payments will be applied to the outstanding balance first.

Thirty Day Notice for Withdrawal

FLA requires 30 days written notice when children are being withdrawn from early education classes. FLA will refund any tuition paid in advance, beyond the 30-day notice, when a written, 30-day notice of intent to withdraw is given to the school.

DISCOUNTS: Members of Christ Community Church are eligible to receive 5% off early education tuition. FLA offers a sibling discount of 10% when two or more children from the same family are enrolled. The 10% discount is taken off the younger child(ren)'s tuition.

FLA Registration Fees:

This one-time registration fee is non-refundable.

Registration fee waived for active military families.

One Child.....	\$75.00
Two or More Children.....	\$100.00

FACTS Family Portal Fee:

This non-refundable fee is charged in August to every family, every school year, by FACTS. If a student enrolls after August, the fee will be charged with their first month's tuition.

If a student is part of a split household and parents pay separately for tuition, each parent will have their own FACTS payment agreement and both parents will be charged this fee.

Toddler Childcare (1 and walking — 2 years old)

Care begins at 7:30a.m. and ends at 5:30p.m. Individual schedule must be given to the office at the time of enrollment.

Full-day care is any time from open to close.

Half-day care consists of drop-off at 8:30a.m. and pick-up 12:30p.m.

Kid Care (3 and potty trained — 5 years old)

Care begins at 7:30a.m. and ends at 5:30p.m. Individual schedule must be given to the office at the time of enrollment.

Full-day care is any time from open to close.

Half-day care consists of drop-off at 8:30a.m. and pick-up at 12:30p.m.

2 Day Program (Full-Day).....	\$450 monthly

Kids' Camp Childcare (K-14 years of age)

These programs are only available to children attending Family Life Academy for Kinder-8th grade.

Before School Program

Hours are from 7:30 a.m. to 8:15 a.m.

After School Program

Care is offered from 2:45p.m. until 5:30p.m.

Before/After School rates are charged on a monthly basis.

2 Day Program	Before \$20	Before/After \$130	After \$120

Childcare is available for early dismissal days and some holidays at the rate of \$6.50/hour.

Summer Camp Childcare (K-14 years of age)

Summer Camp is offered from 7:30a.m. until 5:30p.m. The 2024 camp session begins May 21 and ends July 31.

Summer Camp rates are charged on a weekly basis.

- 5 days per week: \$175
- 4 days per week: \$140
- 3 days per week: \$105
- 2 days per week: \$70

Extended Care/Drop-In Days (all ages)

Drop-in care is offered for currently enrolled FLA students when there is availability in the classroom and upon Early Education Director's approval. Parents must pre-arrange for Drop-in Care by contacting the Director at least 24 hours in advance. Drop-in days are \$6.50 per hour and will be billed at the beginning of the following month.

Families of children who are not picked up by 5:30p.m. (or 12:40p.m. for half day students) may be billed \$1/minute for each minute they are late. If a student is repeatedly picked up past the deadline, the issue will be addressed with the parents and may result in the student being withdrawn.

Schedule Changes

A form is available in the FLA office if you would like to request any sort of schedule change, including drop-in days and vacation credits.

Vacation Credits

We give one week (maximum) vacation credit per calendar year if the child will be absent a full week (5 consecutive school days). To receive this credit, written notice is required to be given to the Early Education Director. If the child has been in attendance for any part of the week, the vacation credit will not be applied.
